Executive Summary

Atlantic Environmental Services, Inc. (AES) conducted a Phase I Environmental Site Assessment (ESA) for Berkley Group's proposed construction of a 175-foot monopole stealth pine tree tower at 5925 Ballantyne Commons Parkway, Charlotte, North Carolina, in Mecklenburg County. The subject is a proposed 100-foot by 100-foot lease area (the Site) for the construction of a wireless telecommunications tower facility. The project also includes an access and utilities maintenance easement from Ballantyne Commons Parkway.

The objective of a Phase I ESA is to identify recognized environmental conditions for a subject site. A recognized environmental condition is defined in ASTM standard E-1527 as "the presence or likely presence of any hazardous substances or petroleum products on a property under conditions that indicate an existing release, a past release, or a material threat of release of any hazardous substances or petroleum products into structures on the property, or into the ground, groundwater, or surface water of the property."

A site visit was conducted on November 13, 2012. The site inspection of the property and surrounding area and the information provided to AES indicated the following:

- The Site is a proposed 100-foot by 100-foot lease area for the construction of a 175-foot monopole communications tower. The tower facility also has a proposed access and utilities maintenance easement from Ballantyne Commons Parkway.
- The Site is located in a wooded area adjacent to I-485. The area surrounding the Site consists of additional woodlands of the parent property, a school, and residential use. The parent property is owned by the Charlotte-Mecklenburg Board of Education.
- Water and sewer service are provided at the parent property by the Charlotte-Mecklenburg Utility Department. Duke Energy provides electrical service and Windstream provides landline telecommunication service in the area. Topography at the Site slopes to the south toward Cady Lake and Flat Branch.
- AES contacted Mr. Todd Sherrill, property manager for the Charlotte-Mecklenburg Board of Education, to obtain further information about the historical use of the Site and parent property. Mr. Sherrill reported no knowledge of environmental conditions, liens, regulatory actions, or use restrictions for the parent property.

Phase I Environmental Site Assessment

Executive Summary

- The surrounding area was found to contain one mapped and several unmapped records in the state and federal environmental databases searched per ASTM standards. A location and status assessment of the mapped and unmapped records was conducted and it has been determined that they are not expected to affect the proposed lease.
- This Phase I Environmental Site Assessment was performed in conformance with the scope and limitations of ASTM Practice E 1527 for the subject lease. Any exceptions to, or deletions from, this practice are described in Sections 2.4, 3.5.2 and 3.6. This assessment has revealed no evidence of recognized environmental conditions in connection with the proposed lease.

1. Introduction

Atlantic Environmental Services, Inc. (AES) conducted a Phase I Environmental Site Assessment (ESA) for Berkley Group's proposed construction of a 175-foot monopole stealth pine tree tower adjacent to Ballantyne Commons Parkway in Charlotte, North Carolina, in Mecklenburg County. The subject is a proposed 100-foot by 100-foot lease area (the Site) for the construction of a wireless telecommunications tower facility. The project also includes an access and utilities maintenance easement from Ballantyne Commons Parkway

This Phase I ESA was conducted in accordance with the American Society for Testing and Materials (ASTM) standards for environmental site assessments for commercial real estate (E 1527-05). The objective of a Phase I ESA is to identify recognized environmental conditions for a subject site. A recognized environmental condition is defined in ASTM standard E-1527 as "the presence or likely presence of any hazardous substances or petroleum products on a property under conditions that indicate an existing release, a past release, or a material threat of release of any hazardous substances or petroleum products into structures on the property, or into the ground, groundwater, or surface water of the property."

AES conducted a walk-through inspection of the property on November 13, 2012, to evaluate existing site conditions. A search of the United States Environmental Protection Agency (USEPA), North Carolina state regulatory environmental databases, and local databases for the area was conducted by Environmental Data Resources, Inc. (EDR). The following sections discuss our research in detail.

Detailed Scope of Services

This assessment has been conducted in general conformance with ASTM E 1527.

The scope, completed by assembly of this report, consisted of the following.

- 1) Obtain and review federal, state regulatory, and local agency records for the site and immediate surrounding area for inclusion in databases listing known areas of environmental risk and/or contamination.
- 2) Perform a site inspection of accessible areas of the property to determine the presence or likely presence of recognized environmental conditions.

- 3) Review aerial photographs and other historical information for the site from readily available sources in order to evaluate changes in site vegetation, topography, and use.
- 4) Assess adjacent property use by observation from the subject site or from adjacent public roadways and contact local regulatory agencies, fire department, neighbors, and previous owners as may be productive in verifying historical use of the property.
- 5) Review site history of ownership, if provided by the user, to determine past uses that were, as described in E 1527-05, “likely to have involved the use, treatment, storage, disposal, or generation of hazardous substances or petroleum products.”
- 6) Prepare a written report documenting the results of the foregoing evaluations and form an opinion of the presence or likely presence of recognized environmental conditions at the site.
- 7) Services associated with evaluation of site buildings, if any, for asbestos, vapor intrusion, mold, and radon are **excluded** from this scope of services.

Significant Assumptions

A Phase I ESA per ASTM standards is an assessment that is based on various assumptions. Assumptions are inherently made by the environmental professional in the site inspection, property research, and reporting tasks involved in completing the process.

In the inspection and research phase, the environmental professional has to assume that the conditions observed during the Site inspection are representative of the unaltered condition of the Site. In addition, the professional has to accept as true the information obtained from the past and present owners, regulatory officials, and other historical and publicly available sources.

In assembling all of the data obtained through the Site inspection and research procedures into a report, the professional also has to make assumptions about the extent, or lack of, impact that may have occurred from an apparent release of a petroleum product or hazardous waste. Further, assumptions have to be made concerning subsurface conditions and how the variables of soil characteristics and groundwater hydrology can affect the fate and transport of contaminants.

2. Background Information

2.1 Site Location/Land Use

The proposed Site is located in a wooded area adjacent to I-485. Areas surrounding the Site consist of other woodlands of the parent property, a school, and residential use. The Site and parent property are located south of Charlotte, North Carolina.

Land use in this area consists of the JM Robinson school and residential use. A vicinity and topographic map for the Site are included in Appendix B.

2.2 Environmental Setting

Data describing the environmental setting of a subject site is used for assessing the potential for migration of contaminants from adjoining properties or from within a parent property. Such data typically includes topographic and geologic sources that can be used to make judgments concerning the transport and fate of contaminants in air, soil, and ground water.

Soils at the Site are classified on the Web Soil Survey as Map Unit: MeB – Mecklenburg fine sandy loam, 2 to 8 percent slopes. These well drained soils are found on interfluves of uplands. The parent material consists of saprolite derived from diorite and/or gabbro and/or diabase and/or gneiss. The depth to a root restrictive layer is greater than 60 inches. Water movement in the most restrictive layer is moderately low and the available water to a depth of 60 inches is high. The shrink-swell potential is moderate. This soil is not flooded or ponded and there is no zone of water saturation within a depth of 72 inches. These soils have a slightly acidic reaction with a pH range from 5.6 to 7.3. The risk for corrosion is moderate for uncoated steel and moderate for concrete.

The Site is in the Weddington, North Carolina, USGS topographic quadrangle. The surface elevation at the Site is approximately 644-feet above mean sea level (msl). Topography at the Site is sloped to the south toward Cady Lake and Flat Branch.

2.3 Facility Operations

The proposed tower facility will operate as an unmanned installation designed to support wireless telephone service equipment.

2.4 Historical Overview

A chain-of-title for the subject property, conforming to ASTM standards, is to be provided by Berkley Group. Title research was therefore not included in the scope of this assessment.

AES contacted Mr. Todd Sherrill, property manager for the Charlotte-Mecklenburg Board of Education, to obtain further information about the historical use of the Site and parent property. He stated that the parent property has likely been owned by the board of education for many years, but was unsure of the date of acquisition. Mr. Sherrill reported no knowledge of environmental conditions, regulatory actions, or use restrictions for the parent property. Mr. Sherrill also reported no knowledge of aboveground or underground fuel tanks, dumping, burning, or burial of hazardous wastes or petroleum materials on the property. He also stated that there are no environmental liens against the parent property.

AES contacted Chief Gary McCormick of the Charlotte Fire Department to obtain historical information on fire calls, spills, or HAZMAT responses at or near the Site. Chief McCormick has not responded to the request for information as of the date of this report. AES will amend this report if Chief McCormick responds with information on environmental conditions at or near the Site.

Sanborn Historical Map research was conducted for the area of the Site. No map coverage is available.

2.5 Review of Aerial Photographs

Aerial images from 1993, 1999, 2002, 2005, 2006, 2008, 2009, and 2010 provided by Google Earth were reviewed. These images show the area of the proposed tower compound as a wooded area throughout the period. The adjoining areas appear to consist of additional undeveloped woodlands and residential use near JM Robinson school.

Aerial images from 2006 and 2009 provided on the Web Soil Survey and Charlotte-Mecklenburg POLARIS website were also reviewed. These images show the area of the proposed Site as described above.

3. User Provided Information

3.1 Title Records

Title records for the subject parcel were not provided by the user for review under the scope of this assessment.

3.2 Environmental Liens or Activity and Use Limitations

The user or current property owner have provided no knowledge of environmental liens against the property and no activity or use limitations other than local zoning ordinances and building codes.

3.3 Specialized Knowledge

No specialized information or knowledge has been provided by the user for the subject property.

3.4 Valuation Reduction for Environmental Issues

A valuation reduction has not been included as part of the scope of this assessment.

3.5 Owner, Property Manager, and Occupant Information

The subject property is currently owned by the Charlotte-Mecklenburg Board of Education. Mr. Todd Sherrill was interviewed as described in Section 2.4.

3.6 Reason for Performing Phase I

This Phase I ESA has been performed to identify recognized environmental conditions for the subject site. The user is interested in determining the likelihood of RECs at or near the subject property and assessing the potential to affect a small lease area on the parent property that will be used for a wireless telecommunications tower facility.

3.7 Other

No other user provided information is noted.

4. Site Inspection

4.1 Inspection

A visual inspection of the Site and surrounding area was made on November 13, 2012. The investigation involved a walk-through of the Site and surrounding area to obtain information on the presence or likely presence of recognized environmental conditions at or near the property.

The site inspection included a walk of the access to the Site across the parent property, as well as a survey of the surrounding properties from public roads.

4.2 Utilities

Water service was not evident in the area of the Site but is provided in the area by the Charlotte-Mecklenburg Utility Department. Windstream provides landline telecommunication service and Duke Energy provides electrical service in the area.

4.3 Wastewater and Stormwater

Sewer service is not in use at the Site but is available to the properties in the area from the Charlotte-Mecklenburg Utility Department. A sewer manhole was noted near the southwest corner of the parent property adjacent to the proposed access road. Stormwater runoff onto and across the Site is from wooded areas and is expected to follow natural drainage patterns to the south-southeast toward Cady Lake and Flat Branch.

4.4 Petroleum and Chemical Materials

There was no evidence of any petroleum or chemical materials at the Site.

4.5 Solid Waste

4.5.1 Non-Hazardous Waste

No non-hazardous waste was observed at, or adjacent to, the Site.

4.5.2 Hazardous Waste

No hazardous waste was observed at, or adjacent to, the Site. Asbestos survey for on-site buildings, if any, was not included in the scope of this assessment.

4.6 Radon

A radon survey was not in the scope of this assessment.

4.7 Polychlorinated Biphenyls (PCBs)

Pad mounted transformers were observed on the electrical service lines located in the area. These transformers appeared to be in good condition with no evident leaks. The transformers are not located such that they would be expected to affect the proposed lease area. Most power companies report that they no longer utilize transformers containing Polychlorinated Biphenyls (PCBs).

5. Regulatory Agency Database Review

5.1 Database Listing

AES subcontracted with EDR to conduct a search of applicable and accessible federal, state, and local databases within a designated radius of the Site. This database search is designed to determine whether the Site or neighboring sites have a regulatory history of environmental problems that could have an adverse impact on the subject property. The EDR report is included as Appendix C. It contains a listing of the relevant databases researched and a brief explanation of the type of information contained in each database.

5.2 On-Site Potential Sources of Contamination

EDR reported no on-site potential sources of contamination.

5.3 Off-Site Potential Sources of Contamination

EDR reported one mapped and several unmapped, off-site potential sources of contamination. The mapped record is for Cato Farms, a SHWS record located approximately 0.5-miles south of the Site. This property is separated from the Site by topography and distance such that it would not be expected to affect the proposed tower facility lease.

The unmapped records were reported by EDR with limited and incomplete address information. An examination of both the estimated location and listed status of these records was conducted to determine if they are likely within the ASTM radii of being a potential source of contamination. The street addresses listed for each unmapped record were cross-referenced with the streets that intersect within a one-mile radius of the Site.

Based on this analysis of the limited address information provided and the reported status of each unmapped record, it has been determined that they are not likely to affect the proposed lease. See Appendix C for details on each record listing.

6. Summary of Findings and Opinion

The site inspection of the property and surrounding area and the information provided to AES indicated the following:

- The Site is a proposed 100-foot by 100-foot lease area for the construction of a 175-foot monopole communications tower. The tower facility also has a proposed access and utilities maintenance easement from Ballantyne Commons Parkway.
- The Site is located in a wooded area adjacent to I-485. The area surrounding the Site consists of additional woodlands of the parent property, a school, and residential use. The parent property is owned by the Charlotte-Mecklenburg Board of Education.

7. Qualifications

He also has experience with industrial and municipal solid waste projects, wetlands delineation, asbestos inspection, construction management, as well as project management in Wireless Telecommunications and Land Development.


